

INDIANA CHOICE SCHOLARSHIP APPLICATION PROCESS For Lutheran High School

This is the process to sign up for the Indiana Choice Scholarship at Lutheran High School of Indianapolis (LHS). Family/Household qualifications:

- ⇒ family/household meets one of the seven tracks in the list below
- -AND- \Rightarrow family/household meets the income qualifications in the table below
- 1: Complete the student <u>enrollment</u> for Lutheran High School through ParentsWeb.
- 2: Submit the family <u>financial aid application</u> at <u>online.factsmgt.com/aid</u>. We encourage you to begin the application process January 1, and then upload your 2018 tax information at a later date. There is a \$35 fee to FACTS for this application process. The priority deadline is <u>March 15, 2019</u>. This confidential process completes your **income review for both the Choice Scholarship program and financial aid** through Lutheran High School.
- ____ 3: Complete the attached Lutheran High School Choice Scholarship Applicant Information Form (one for each student). Please remember to sign the back of the form and return it to the LHS office in person or by email to Bev McIntosh at bmcintosh@lhsi.org. Once all the paperwork is received and the State approves the application:
 - a) You will need to sign and return the final State approval letter.
 - b) You will receive a letter via email with your Choice Scholarship amount and/or financial aid amount that will need your signature before your payment plan can be adjusted.

Seven Tracks to Receive an Indiana Choice Scholarship

- A. The student received a Choice Scholarship last year.
- B. The student received a Choice Scholarship in a different previous year.
- C. The student received an SGO Scholarship in any previous year.
- D. The student has an Individualized Education Program (IEP) or a service plan.
- E. The student would go to an "F" rated school if attended public school of record.
- F. The student attended the last two semesters in a public school.
- G. A sibling of the student received either a Choice Scholarship or an SGO Scholarship in any previous year.
